# **SECTION 4) FIRST-AID MEASURES**

#### Inhalation

### **Eye Contact**

### **SECTION 5) FIRE-FIGHTING MEASURES**

#### Suitable Extinguishing Media

Use dry chemical, CO2, alcohol-resistant foam or water spray (fog). Use water spray cautiously to keep fire-exposed containers cool.

# **Emergency Procedure**

Isolate hazard area and keep unauthorized personnel away. Stay uphill and/or upstream. Do not touch damaged containers or spilled materials unless wearing appropriate protective clothing. Ventilate closed spaces before entering.

#### **Recommended Equipment**

Wear chemical protective clothing.

#### **Personal Precautions**

Avoid breathing vapor or mist. Avoid contact with skin, eye or clothing.

#### **Environmental Precautions**

Stop spill/release if it can be done safely. Prevent spilled material from entering sewers, storm drains, other unauthorized drainage systems and natural waterways by using sand, earth, or other appropriate barriers. Dike far ahead of liquid spill for later disposal.

#### Methods and Materials for Containment and Cleaning up

Absorb Liquids in vermiculite, dry sand, earth, or similar inert material and deposit in sealed containers for disposal.

# **SECTION 7) HANDLING AND STORAGE**

#### General

Wash hands after use. Do not get in eyes, on skin or on clothing. Do not breathe vapors or mists. Use good personal hygiene practices. Eating, drinking and smoking in work areas is prohibited. Remove contaminated clothing and protective equipment before entering eating areas. Eyewash stations and showers should be available in areas where this material is used and stored All containers must be properly labelled. Store in original containers, above -15oC / 5oF. Storage life of factory-sealed containers is 24 months. Choline chloride solutions are corrosive to certain commonplace steels & other metals. Always check the choline chloride resistance of pumps, bulk tanks, valves, metering equipment, etc before putting into service. Polyvinyl chloride, polyethylene & fibreglass reinforced plastics are resistant. Always ensure that containers, empty or full, are tightly sealed unless in use.

### **Ventilation Requirements**

Use only with adequate ventilation to control air contaminants to their exposure limits.

#### **Storage Room Requirements**

Store in dry, cool areas, out of direct sunlight and away from other sources of heat. Empty container retain residue and may be dangerous.

#### Eye protection

Wear indirect-vent, impact and splash resistant goggles when working with liquids

#### **Skin Protection**

Use of gloves approved to relevant standards made from the following materials may provide suitable chemical protection: PVC, neoprene or nitrile rubber gloves. Suitability and durability of a glove is dependent on usage, e.g. frequency and duration of contact, chemical resistance of glove material, glove thickness, dexterity. The type of protective equipment must be selected according to the concentration and amount of the dangerous substance at the specific workplace.

#### Respiratory Protection

If engineering controls do not maintain airborne concentrations to a level which is adequate to protect worker, a respiratory protection program that meets or is equivalent to OSHA 29 CFR 1910.134 should be followed. Check with respiratory protective equipment suppliers.
